Catalogue Course Description:

This course will examine the art and architecture of Europe and the Mediterranean region from approximately the 4th to the 14th centuries.

Expanded Course Description:

This course will examine the artistic production of Europe and the Mediterranean in the early Middle Ages, particularly the 4th-10th centuries, with attention to how it was shaped by the material, iconographic, and ideological legacy of the Roman Empire. We will consider questions such as the self-definition of rulers and dynasties as the legitimate heirs of the Romans, the material re-use of the past, and the conceptual recreation or stylistic imitation of historical forms by examining a range of artistic media, from monumental architecture and sculpture to manuscript miniatures and jewelry.

Course Goals:

- Provide an overview of the history of art from the 4th through 10th centuries in Europe and the Mediterranean Region.
- Inform students about the variety of social, cultural, and economic contexts in which art was produced and used in order to explain how these contexts affected the objects' form and function.
- Heighten visual acuity and increase facility in communicating about works of art and architecture, as well as other aspects of the visual environment.
- Guide students to critically read and analyze scholarly and primary source texts and to relate art works to them.

Student Learning Outcomes:

Upon successful completion of this course, students will be able to...

Identify, describe, and interpret works of art, architecture, and material culture from the 4th century to circa 1300 CE in Europe, the Mediterranean Basin, and the Near East, while also recognizing the works' continued importance in our contemporary world. (Content SLO: N)

- These outcomes will be assessed through class participation, the group project, exams, and the annotated bibliography.

Use the methods and vocabulary of art history to analyze how works of art and architecture and the cultural, economic, political, and/or social systems surrounding their creation mediate our understanding of both the past and the contemporary world. (Critical Thinking SLO: N)

- These outcomes will be assessed through the group project, exams, and the annotated bibliography.

Formulate oral and written analyses of works of art and architecture from this period in their historical and cultural context, while also reflecting on the ways that works of art and architecture mediate understanding of the contemporary world. (Communication SLO: N)

- These outcomes will be assessed through the group project, exams, and the annotated bibliography.

Requirements:

Description of Graded Work

Attendance 5%

Much of the test material will come from lectures and discussions. Participation: 10%

Each class meeting will include discussion of the week’s readings and other material presented in class. Students are assigned 3 points per course hour each week based on their participation (see the participation rubric below). A percentage is calculated based on the total number of participation points available in a semester, usually about 100. This then counts as 15% of the overall grade. If you have issues that inhibit you from joining freely in class discussion, please see the instructor as early in the semester as possible to discuss alternative modes of participation.

Group Project 15%

Students will be assigned to small groups to conduct investigations into archaeological/art historical “mysteries.” Each group will be presented with a set of archaeological, historical, and art historical evidence, and a research question. For the first part of the assignment (5%), the group will work together to propose an answer to the question based on the provided evidence. For the second part of the assignment (5%), students will read and analyze published scholarly research on the question, and compare the authors’ conclusions to the group’s hypothesis. Each group will make an oral presentation to the class on their project (5%).

Annotated Bibliography 25%

In lieu of a full research paper, students will propose an original research question, and prepare an annotated bibliography of scholarly sources addressing their question. The assignment will be completed in three phases: a proposal of 1-3 ideas for a research question, to be discussed with the instructor (5%); a draft annotated bibliography (10%); a final annotated bibliography (10%). The bibliography should be as comprehensive as necessary to address the research question. The annotation for each source should briefly summarize the source’s argument and role in the scholarship, and detail how the student would make use of it in the hypothetical research paper.

Midterm Exam 25% and Final Exam 30%

The midterm and the final are both in-class exams and will consist of three timed sections: three extended ID responses (15 minutes), a short essay comparing two images (one on the midterm and two on the final exam; 15 minutes each), and a longer essay question (30 minutes). The midterm will be 60 minutes total and the final exam will be 75 minutes total. Exam content will be drawn from readings, terms, and examples discussed in class. A list of study images will be provided. This information will be posted along with more details on expectations and grading on Canvas under the Midterm and Final Exam tabs on the "Assignments" page.

All assignments must be submitted via **Canvas** and are due at **midnight** unless otherwise noted.
